<u>Notice concerning Revision to Distribution Forecast for Fiscal Period Ended</u> <u>February, 2009 (Sixth Fiscal Period)</u>

LCP Investment Corporation (the "Investment Corporation") today announced that it revised its forecast of distribution per unit for the fiscal period ended February, 2009 (from September 1, 2008 to February 28, 2009) disclosed on December 26, 2008.

1. Rationale for the Revision

The Investment Corporation has revised its forecast of distribution per unit for the fiscal period ended February, 2009 disclosed on December 26, 2008 as a result of the distribution forecast revision since most of its operation results for the fiscal period became clear. The rationale for the revision is decrease in interest costs due to declining market interest rates.
