# (Correction) Notice concerning Partial Correction of "Invincible Investment Corporation June 2023 Fiscal Period Results" and "Invincible Investment Corporation December 2023 Fiscal Period Results"

Invincible Investment Corporation ("INV") hereby announces corrections to its "Invincible Investment Corporation June 2023 Fiscal Period Results" dated August 24, 2023 and "Invincible Investment Corporation December 2023 Fiscal Period Results" dated February 26, 2024 as follows. This correction is due to the fact that the figures for variable rent hotel (variables) and variable rent hotel (fixed) on page 5 were listed in reverse, however, there is no correction for the total amount of operating revenue on page 5. As such, as these figures were not used in other disclosure materials, there are no corrections for the following documents for the June 2023 Fiscal Period and the December 2023 Fiscal Period: "Financial Summary", "Asset Management Report ", and "Securities Report (available in Japanese only)". Further, there is no correction for the press release "Notice concerning Revision of Forecast of Financial Results and Distribution for the 41st Fiscal Period Ending December 2023 and 42nd Fiscal Period Ending June 2024, together with Forecast of Financial Results and Distribution for the 43rd Fiscal Period Ending December 2024".


