### Notice concerning Changes to Organization and Key Employee of Asset Manager

Invincible Investment Corporation (INV) announces today that its asset manager, Consonant Investment Management Co., Ltd. (the "Asset Manager"), has decided to make organizational changes as well as change in key employee as follows.

#### 1. Organizational Change

(1) Details of the Change

The Asset Manager will establish the Internal Audit Department.

## (2) Purpose of the Change

The purpose of the change is to strengthen the internal audit system and further enhance governance at the Asset Manager. The Internal Audit Department will be in charge of the internal audit duties currently handled by the Compliance Officer, and will perform the audit function under a clearer and more independent structure. For the time being, the current Compliance Officer will temporarily serve as the head of the Internal Audit Department, but the Asset Manager plans to appoint the head of the department dedicated to internal audit duties in the near future.




# [Reference 1] Structure of Organization <Before Change>
