#### 2. Reason for Revision

The revision to the forecast results was decided to be made at this time due to the fact that a review of the forecast revealed that a 30% change is expected from the previously announced forecast for the 11<sup>th</sup> Fiscal Period results.

#### 3. Future Forecasts

The fixed distribution for the 11<sup>th</sup> Fiscal Period and the forecast of TGR's results for the 12<sup>th</sup> Fiscal Period (July 1, 2008 - December 31, 2008) will be announced in the Financial Summary for the 11<sup>th</sup> Fiscal Period.

In addition, the announcement of the Financial Summary for the 11<sup>th</sup> Fiscal Period is scheduled to be made on August 13, 2008.
