Notice concerning Execution of Loan Agreements on the New Borrowings and Amendment Loan Agreement regarding Changes of the Borrowing Terms on the Existing Borrowing and Determination of Interest Rates

Invincible Investment Corporation (INV) has announced that it has executed on July 27, 2011 the loan agreements regarding the new borrowings (the Term Loan (Shinsei Trust A) (hereinafter, the "Shinsei Trust Loan A"), the Term Loan (Syndicate A) (hereinafter, the "Syndicate Loan A"), the Term Loan (Shinsei Trust B) (hereinafter, the "Shinsei Trust Loan B") and Debt financing backed by trust assets (Prudential LPS) (hereinafter, the "Prudential LPS Loan")), and the amendment loan agreement regarding partial repayment and partial changes of its borrowing terms of an existing borrowing, the Term Loan (Shinsei Trust & Banking Co., Ltd.) (hereinafter, the "Securitized Loan"), which had been disclosed in the press releases titled "Notice concerning Debt Financing and Repayment of Borrowings, etc. (1)", "Notice concerning Debt Financing and Repayment of Borrowings, etc. (2)" and "Notice concerning Fund Procurement through Debt Financing Backed by Trust Assets and Repayment of Borrowings and Change in Trustee of Trust Assets", all dated July 15, 2011.
